Registration of chemical compositions by suppliers of chemical products

Companies importing chemical products to Sweden are obliged to report their products to the Swedish Chemicals Agency. If they do not have access to the composition details of the products they need help from their supplier. Otherwise the importing company will not be able to fulfil its obligations. You as a supplier might need to report the product composition to the Swedish Chemicals Agency. The information you provide will be handled as confidential. This fact sheet tells you how to do it.

All companies manufacturing or importing chemical products to Sweden are obliged to report their products to the Products Register at the Swedish Chemicals Agency.

The legal basis for this is the legal act *Chemical Products and Biotechnical Organisms Ordinance, 2008:245* (only in Swedish).

It is mandatory for those companies to report all substances considered hazardous to health and/or environment, as well as all other substances that make up at least 5% of the content.

The legal basis for that is the *Swedish Chemical Agency's Chemical products and biotechnical organisms regulation (KIFS 2017:7)* (only in Swedish).

In some cases, the importing company does not have access to the composition details of the products. In this case you, the supplier, will have to report the complete chemical composition, each substance with exact concentration, to the Swedish Chemicals Agency.

The composition data should be reported as a Product-In-Product (PiP) in the web portal of



If you sell chemical products to companies importing chemical products to Sweden you might need to report the product composition to the Swedish Chemicals Agency. This fact sheet tells you how to do it.

the Products Register. The PiP will be given a registration number, a so-called A-number. When you provide your customer with this A-number they can refer to it in their product declaration.

The supplier is seen as a data provider only and will not have to pay a chemical fee.

Access to data

Companies submitting data to the Products Register only have access to their own data. Any information provided is protected by a security marking in the database and is therefore only available to the security checked registry staff at the Swedish Chemicals Agency.

How to register a PiP?

If your company is not registered in the Products Register before, you must start by registering your business. Follow the instructions on the website.

The composition is described by the chemical substances and their respective exact percentage by weight.

Don't forget to make your A-number searchable for your customer.

Secrecy

The general rule is that secrecy applies to information about the business activities or operating conditions of individual parts where it can be anticipated that the individual part will suffer if such information will be disclosed.

This rule applies for example for the composition data, the quantity of the product and the

supplier name in the Swedish Products Register.

The regulations on secrecy are found in *the Public Access and Secrecy Act (2009:400)* Chapter 30, section 23 and the *Ordinance (2009:641)* section 9 and Annex to the Ordinance, points 46 and 82.

About the Swedish Products Register

The Swedish Chemicals Agency uses the Products Register to store information on chemical products and biotechnical organisms that are manufactured in or imported into Sweden.

The Products Register is an important tool for the Swedish Chemicals Agency and authorities monitoring public health, workplace safety and environmental protection. The register gives us an overview of the use of chemicals in Sweden and enables us to produce statistics and provide data for official statistics in Sweden.
